As volunteer representatives of the membership of Southwest Federal Credit Union, Board Members review the financial condition of the credit union, make decisions on the direction of the credit union and set the vision for the future of Southwest Federal Credit Union. Volunteers must be able to attend a monthly meeting. Generally, Board Members will need to dedicate about six (6) hours a month to conduct Southwest Federal Credit Union business.
