Any Primary adult member in good standing is eligible to run for a three-year term on the Board of Directors.

**Board of Directors Petition Process:**

Nominations may also be made by petition, signed by one percent (1%) of the membership. (A minimum of 50, maximum of 500 signatures.) All petitions should include a brief statement of qualifications, and biographical data to be submitted with the application and signatures by April 11, 2019 to be considered for the May 21, 2019 Annual Meeting.

**What do the Board/Volunteer Members Do?**

As volunteer representatives of the membership of Southwest Federal Credit Union, Board Members review the financial condition of the credit union, make decisions on the direction of the credit union and set the vision for the future of Southwest Federal Credit Union. Volunteers must be able to attend a monthly meeting. Generally, Board Members will need to dedicate about six (6) hours a month to conduct Southwest Federal Credit Union business.
