In light of the current events taking place in the world, cybersecurity agencies are on high alert. Please follow a few simple guidelines and be aware of red flags on all incoming emails such as:

- Sender's email address is different from company email.
- Sender is requesting immediate action without confirmation.
- Sender is unknown.
- Topic or message is unexpected from a known sender.
- Any online banking login credentials are being requested or advising you to verify using a link.

You may have noticed our monthly account statements have a new look. They are now generated by the same company that processes all our data and maintains our website. As a result, the new look ties in more closely with our on-line statements.

Previously, we were outsourcing our statements, which means data was sent to a third party. In the past, the process of coordinating with the third party and our data processor has resulted in delays in statement distribution. Not only was this inconvenient to you, our members, but it has also become cost prohibitive.
